The undersigned hereby executes the following amended Articles of Incorporation (Articles) pursuant to the Washington Nonprofit Corporations Act (RCW 24.03, et. Seq.) (Act) in order to amend provisions of the original Articles of Incorporation dated August 14, 1992, and all amendments thereto.

**ARTICLE I
Name and Period of Duration**

The name of this corporation shall be Cascade Medical Foundation (Foundation), and its existence shall be perpetual until dissolved in accordance with Washington state law.

**ARTICLE II
Purposes**

The purposes for which this Foundation is formed are to perform the following activities solely for the benefit of Public Hospital District # 1, Chelan County, Washington within the permitted activities of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (Code) and include the following activities:

1. Promote Public Hospital District # 1, Chelan County, Washington.
2. Initiate, develop and work on fundraising activities.
3. Accept gifts and pledges of money, property and/or financial assets and securities given to the Foundation.
4. Encourage consistent giving to benefit Public Hospital District # 1, Chelan County, Washington.
5. Manage these financial resources and gifts for the present and the future.
6. Engage in any other lawful activity which may hereafter be authorized from time to time by the Board of Directors (Board) of the Foundation, provided, however, that the purposes for which the Foundation is formed shall at all times comply with Section 501(c)(3) of the Code, as currently enacted or hereafter amended.
7. Distribute funds for the needs of Hospital District # 1, Chelan County, Washington, as approved by the Board.

**ARTICLE III
Powers**

This Foundation shall have the authority to take any lawful action necessary, appropriate or desirable to carry out its purposes consistent with the Act, as currently enacted or hereafter amended, and section 501(c)(3) of the Code and consistent with these Articles of Incorporation and the Foundation's Bylaws, and applicable amendments thereto.

ARTICLE VII Indemnification

The Foundation shall provide for General Liability and Director's and Officer's Liability Insurance as provided in the Agreement with Public Hospital District, Chelan County, Washington for Fundraising Services (Agreement), effective April 1, 2019. The Foundation also has the authority to indemnify its Directors, Officers and other persons against all liability, damages and expenses arising from or in connection with service for, employment by or other affiliation with the Foundation or other firms or entities to the maximum extent and under all circumstances permitted by law.

ARTICLE VIII
Limitation of Liability of Directors and Officers

A Director or Officer of the Foundation shall not be personally liable to the Foundation for monetary damages for conduct as a Director or Officer, except for liability of the Director or Officer (i) for acts or omissions that involve intentional misconduct by a Director or Officer or in knowing violation of law by a director or officer; (ii) for conduct in violation of the Act as currently enacted or hereafter amended; or (iii) for any transaction for which the Director or Officer will personally receive a benefit in money, property or services to which the Director or Officer is not legally entitled. If the Act authorizes or is amended to authorize corporate action further eliminating or limiting personal liability of Directors and Officers, then the liability of Directors and Officers of the Foundation shall be eliminated or limited to the fullest extent permitted by the Act, as so amended. Any repeal or modification of this Article VIII by the Directors or Officers of the Foundation shall not adversely affect any right or protection of a Director or Officer of the Foundation existing at the time of such repeal or modification.

ARTICLE IX
Disposition of Assets upon Dissolution

Upon dissolution of the Foundation, the Board shall, after paying or making provisions for the payment of all liabilities of the Foundation, distribute the remaining assets of the Foundation to Public Hospital District # 1, Chelan County, Washington, as stipulated in the Foundation Bylaws, section 2.03c.

ARTICLE X
Amendment

The Foundation reserves the right to amend, alter, change or repeal any provisions contained in these Articles in the manner now or hereafter prescribed by law.
